- 1. UPON NOTICE OF DAMAGES, RUST AND/OR SHORTAGES, A WRITTEN NOTICE MUST IMMEDIATELY BE SENT TO US BY FAXING THE TRAFFIC DEPARTMENT ATTN. LUCILA M. GUIBU.AT (713) 965-9330. FOR UNPACKED MATERIAL WE MUST RECEIVE YOUR CLAIM NOTICE WITHIN 30 DAYS FROM RELEASE DATE, FOR WRAPPED MATERIAL, THE TIME LIMIT IS 90 DAYS FROM RELEASE DATE.
 - PLEASE STOP FURTHER PROCESSING OF OUR MATERIAL UNTIL YOU RECEIVE ADVICE FROM US.
- 2. WE NEED PROOF/EVIDENCE FOR THE DAMAGES AND OR SHORTAGES, PLEASE FURNISH TO US DOCK DELIVERY RECORDS, AND /OR TRUCK BILLS OF LADING AND PHOTOS AS EVIDENCE FOR YOUR CLAIM.
 - IT IS IMPORTANT THAT YOUR TRUCKER INDICATES ON THE BILL OF LADING ALL EXCEPTIONS FOR ANY DAMAGES AND/OR SHORTAGES AT TIME OF PICK-UP. IF SUCH EXCEPTIONS ARE NOT NOTED; IT MAY BE CAUSE FOR CLAIM REJECTION. UPON THE DELIVERY TO YOUR WAREHOUSE/SERVICE CENTER, AGAIN, ALL EXCEPTIONS MUST BE NOTED.
